ORDER CONSOLIDATING DOCKETS UE-170485 AND UG-170486 WITH DOCKETS UE-171221 AND UG-171222

PROCEEDINGS. On May 26, 2017, Avista Corporation, d/b/a Avista Utilities (Avista or Company) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective Tariff WN U-28,

Electric Service, in Docket UE-170485 and revisions to its currently effective Tariff WN U-29, Natural Gas, in Docket UG-170486, designed to effect general rate increases for electric and natural gas services. On December 22, 2017, President Trump signed H.R. 1 – An Act to provide for reconciliation pursuant to titles II and V of the concurrent resolution on the budget for fiscal year 2018 (TCJA) into law. The TCJA's most notable impact for utilities regulated by the Commission is the reduction of the federal corporate tax rate from 35 percent to 21 percent.

- On December 29, 2017, the Company filed petitions requesting an order from the Commission authorizing Avista to use deferred accounting for the impact of the TCJA on its federal income tax expenses. These petitions were designated as Docket UE-171221, for Avista's electric operations, and Docket UG-171222, for its natural gas operations.
- NOTICE OF INTENT TO CONSOLIDATE. On February 16, 2018, the Commission issued a notice of intent to consolidate in Dockets UE-170485 and UG-170486 (consolidated) with Dockets UE-171221 and UG-171222 for final decision in these proceedings. The general rate case proceeding in Dockets UE-170485 and UG-170486, and the accounting petitions in Dockets UE-171221 and UG-171222, both involve facts relating to the impacts of the TCJA on the Company's operations.
- On February 23, 2018, the Industrial Customers of Northwest Utilities (ICNU) and the Northwest Industrial Gas Users (NWIGU),¹ the Public Counsel Unit of the Washington Office of the Attorney General (Public Counsel),² and the Commission's regulatory staff (Staff)³ filed comments in support of consolidation of the dockets. On February 28, 2018, Avista also filed comments stating it "agrees with the Parties that [consolidation of the dockets] will promote administrative efficiency and judicial economy."⁴

DOCKETS UE-171221 and UG-171222 ORDER 01

Pursuant to WAC 480-07-320, the Commission may consolidate two or more proceedings in which the facts or principles of law are related. The Commission finds that the facts and principles of law are related, and consolidation would promote judicial economy and administrative efficiency. It is appropriate that Dockets UE-170485 and UG-170486 are consolidated for determination with Dockets UE-171221 and UG-171222.

ORDER

THE COMMISSION ORDERS That Dockets UE-170485 and UG-170486 are consolidated with Dockets UE-171221 and UG-171222 for determination pursuant to WAC 480-07-320. All four dockets are consolidated under Docket UE-170485.
