Suzanne,

The Colorado case that you reference is related to a related Colorado case before the same judge, where my employer (Wellons) obtained a final judgment in the amount of \$10.84MM against Eagle Valley Clean Energy, LLC and its parent company Evergreen Clean Energy Corporation (see attached judgement).

It is our belief that the Eagle Valley's lawsuit is frivolous and was nothing more than an attempt to delay Wellons collecting on the judgment. I have attached both a copy of Eagle Valley's complaint in this case and our motion to dismiss, which will provide you with greater detail as to what is going on.

Please note that the parties have also entered into a global settlement agreement where if Eagle Valley pays the amount of \$10.9MM on or before Nov 13, all claims and lawsuits that the parties

have with each other will be settled.

The Colorado lawsuit has nothing to do with the Sustainable Holdings project, and does not have the potential to provide any impact.
