Pursuant to WAC 480-90-198, Notice Verification and Assistance, Puget Sound Energy ("PSE") is providing this statement that it has published the attached notice in the above-referenced docket in accordance with WAC 480-90-194, Publication of Proposed Tariff Changes to Increase Charges or Restrict Access to Services.

On May 31, 2019 and September 16, 2019, PSE filed with the Commission revisions to its natural gas Schedule 149 Cost Recovery Mechanism for Pipeline Replacement. Approximately 840,000 natural gas customers would see an increase in their bills due to the effect of the proposed changes. PSE posted the above-referenced filing in accordance with WAC 480-90-193(1), Posting of Tariffs for Public Inspection and Review; Web, Telephone, and Mail Access by posting on PSE's web site.

Published notice of the filing was completed in accordance with WAC 480-90-194(2), Publication of Proposed Tariff Changes to Increase Charges or Restrict Access to Services; Published Notice, in the form of a published notice in area newspapers. A copy of the published notice that appeared in area newspapers on October 1, 2019, is attached. PSE also provided a copy of the notice to community agencies, posted the notice on PSE.com and provided notice to news editors of area newspapers, television and radio stations.
