## Re: Docket UE-190575 (Advice No. 2019-29) PSE's Electric Tariff Filing – <u>Do Not Redocket</u>

Dear Mr. Johnson:

Puget Sound Energy ("PSE") submits in connection with Docket UE-190575 the following tariff sheets to replace the tariff sheets that accompanied PSE's June 28, 2019 filing which was submitted under PSE's Advice No. 2019-29. At the request of Commission Staff, PSE additionally withdraws Attachments B to electric Schedule 152 which was newly included in this docket with PSE's July 22, 2019 substitute filing. This filing includes the following portion of the Company's WN U-60 tariff for electric service.

The purpose of this substitute filing made at the request of Commission Staff is to, 1) remove proposed changes to one-time charges (a revised original cover letter dated June 28, 2019 is also included which removes Attachment B to Schedule 152), and 2) remove the reference to Schedule 171, Non-Communicating Meter Service.

The original filing proposed a \$145.00 Application Fee for Net Metering Systems up to 100 kW that use UL Listed inverter-based technology, a \$150.00 one-time Aggregation Set-Up Charge, and an Excess Site Visit Fee of \$240. PSE agrees with Commission Staff's suggestion to include these proposed charges in a separate filing at a later date, and at this time is removing them from this filing.

At Commission Staff's suggestion, PSE is removing verbiage from the Availability Section of Schedule 150 which states that customers taking service under that schedule are not eligible for PSE's Electric Schedule 171, Non-Communicating Meter Service. Currently, as per the Tariff Schedule 171, customers taking service under Schedule 171 will not be eligible for service under Schedule 150<sup>1</sup>.

The tariff sheets described herein reflect the original issue date of June 28, 2019, and effective date of July 28, 2019. Posting of proposed tariff changes, as required by law and the Commission's rules and regulations, is being made by posting the proposed tariff sheets and attachments on the PSE web site in accordance with WAC 480-100-193. This tariff change does not increase recurring charges nor restrict access to this optional service.
