DISPOSITION: AMENDED PROPOSED BUDGET FOR ISSUE FUND GRANT APPROVED

On April 23, 2020, the Alliance of Western Energy Consumers (AWEC), formerly known as the Northwest Industrial Gas Users, filed a proposed budget for an Issue Fund Grant in this proceeding. On May 11, 2020, AWEC filed an amended proposed budget. AWEC's amended proposed budget shows eligible expenses in the amount of \$65,375; and it seeks an Issue Fund Grant in the amount of \$41,005.

The Fourth Amended and Restated Intervenor Funding Agreement (IFA), approved by the Commission in Order No. 18-017, provides that precertified intervenors must submit a proposed issue fund budget to the Commission that contains, at a minimum, the following information:

- 1) A statement of the work to be performed;
- 2) A description of the areas to be investigated;
- 3) A description of the particular customer class(es) that will benefit from the intervenor's participation;
- 4) Identification of the specific fund accounts from which the intervenor is seeking monies and an estimate of the amount of available funds in that account;
- A budget showing estimated attorney, consultant and expert witness fees, which may include the cost for appropriate support staff and operations support; and
- A representation that the intervenor will use matching funds in the form of either in-house resources or outside funding to account for or pay at least 20 percent of the eligible expenses for which the intervenor is seeking an Issue Fund Grant.

Once a proposed budget is received, the Commission decides whether Issue Fund Grants are available for use based on factors identified in the agreement. The Commission has the authority to accept, deny or partially deny the request, and may place reasonable conditions on the grant.

AWEC became precertified as the Northwest Industrial Gas Users on February 3, 2004, in Order No. 04-055. AWEC's proposed budget includes the requisite information and reflects the current schedule adopted in this docket.

In light of the issues being addressed, the complexity of the issues and the significant policy decisions to be made, the Commission believes that AWEC's amended proposed budget is reasonable and should be approved.

ORDER

IT IS ORDERED that:

- 1. The Alliance of Western Energy Consumers' amended proposed budget for an Issue Fund Grant is approved.
- 2. An Issue Fund Grant is approved up to \$41,005.

Pursuant to Section 7.3 of the Fourth Amended and Restated Intervenor Funding Agreement ("IFA") approved by the Public Utility Commission of Oregon ("Commission") in Order No. 18-017 (January 17, 2018), Alliance of Western Energy Consumers ("AWEC") hereby requests payment of a portion of AWEC's Issue Fund Grant in Docket No. UG 389 in the amount of \$24,667.04. In support of this request, AWEC states the following:

- 1. On May 11, 2020, AWEC, fka Northwest Industrial Gas Users ("NWIGU"), filed an <u>amended</u> Proposed Issue Fund Budget in this docket in the amount of \$65,375 less in-house resources of 20 percent, for a total grant request of \$52,300. However, due to the amount available in the Avista Issue Fund, AWEC requested a total Issue Fund Grant request of \$41,005. The Commission approved the Issue Fund Grant in the amount of \$41,005 on May 12, 2020. *In the Matter of Avista Corporation, dba Avista Utilities, Request for a General Rate Revision*, OPUC Docket No. UG 389, Order No. 20-160 (May 12, 2020).
- 2. This case involved Avista's request to increase Oregon revenues by \$6.7 million and involved revenue requirement, cost of capital, and rate spread and rate design issues. After filing testimony and participating in multiple settlement conferences, the

parties were able to settle all of the issues in this docket, and the Commission issued an order approving the comprehensive settlement on December 10, 2020. AWEC hereby requests that the Commission authorize payment of a portion of the approved Issue Fund Grant in this docket in the amount of \$24,667.04. AWEC's Eligible Expenses for this proceeding through December 2020 are shown in Confidential Attachment A.

3. AWEC respectfully submits that this request for payment satisfies the requirement of IFA Section 7.3 as follows:

Section 7.3(a) - The itemized expenses, payees and hourly rates are attached as Confidential Attachment A.

Section 7.3(b) - AWEC was a full and active participant in this docket. AWEC issued and reviewed discovery, filed testimony and reviewed the testimony of other parties, participated in multiple settlement conferences, negotiated several stipulations and filed testimony in support of the stipulations. The expenses included in Confidential Attachment A are Eligible Expenses as defined in IFA Section 7.4 and are reasonable and directly attributable to AWEC's participation in UG 389 on behalf of all customers.

Section 7.3(c) – The only condition of the Issue Fund Grant is that AWEC must contribute 20% of Eligible Expenses using in-house resources. AWEC used its own funds to pay for at least 20% (\$6,166.76) of the Eligible Expenses as required by Section 6.5 of the IFA.

<u>Section 7.3 (d)</u> – This request is a request for final payment of a portion of the approved issue fund in this docket.

4. <u>Section 7.4</u> – All of the expenses included in Confidential Attachment A are Eligible Expenses as defined in Section 7.4 of the IFA and are consistent with AWEC's proposed budget in this proceeding.

5. Upon approval of this request for payment by the Commission, Avista should send payment to AWEC as follows:

6. DISPOSITION: ISSUE FUND GRANT REQUEST APPROVED

On January 8, 2021, the Alliance for Western Energy Consumers (AWEC), formerly known as the Northwest Industrial Gas Users (NWIGU), filed a Request for Payment of its Avista Corporation, dba Avista Utilities Issue Fund Grant. Section 7.3 of the Fourth Amended and Restated Intervenor Funding Agreement (Agreement), adopted by the Commission in Order No. 18-017, governs the procedures for payment of Issue Fund Grants. AWEC was precertified as NWIGU to receive Issue Fund Grants on February 3, 2004, in Order No. 04-055.

AWEC asks for a progress payment of \$24,667.04 from the Avista Utilities' Issue Fund and requests that the remainder of the approved issue fund may be released back into the Issue Fund account. Under the Agreement, the Request for Payment must:

- 1) Itemize the expenses, payees and hourly rates of amount to be reimbursed;
- 2) Demonstrate that the expenses are reasonable and are directly attributable to issues and positions pursued on behalf of a particular customer class and consistent with the intervenor's proposed budget;
- 3) Provide information sufficient to show that the intervenor has complied with any conditions imposed on the Issue Fund Grant; and
- 4) Specify whether the request for payment is for a progress payment or a final payment and indicate whether any approved budget amount may be released back to the applicable Issue Fund.

Further, under the terms of the Agreement, AWEC must establish that it has "used inhouse resources or outside funding to account for or pay at least 20% of the Eligible

Expenses for the work to be performed in the proceeding for which the intervenor is seeking an Issue Fund Grant." Agreement at 15. AWEC provided the required documentation in its request.

The Agreement provides that the Commission will make a determination in each proceeding as to how the participating utilities are to recover the funding grants from the various customer classes. Under Section 7.7(b), Issue Fund Grants should be allocated so as to fairly align the costs of the advocacy with the intended potential beneficiaries of the advocacy. Agreement at 23. The Commission has considered the intended beneficiaries, and finds that the issue fund expenditures should be allocated to Avista Utilities' industrial customers.

The Commission finds that AWEC has met the requirements of the Agreement, and its request should be approved. Section 7.8 of the Agreement provides that the utility must pay the Issue Fund Grant to the requesting intervenor within 30 days after receipt of the Commission directive.

ORDER

IT IS ORDERED that:

- 1. The Alliance of Western Energy Consumers has met the requirements of the Fourth Amended and Restated Intervenor Funding Agreement, and its request is approved.
- 2. Avista Corporation, dba Avista Utilities pay \$24,667.04 from the Avista Utilities' Issue Fund to the Alliance of Western Energy Consumers within 30 days after receipt of this Order, and the grant be assessed to Avista Utilities' industrial customers.

Alliance of Western Energy Consumers ("AWEC") files this request for payment of a Preauthorized Matching Fund Grant for costs incurred from October 1, 2020 through March 31, 2021 from the Avista Utilities ("Avista") Preauthorized Matching Fund Account in the amount of \$10,064.99. This request for payment is filed pursuant to Section 7.2 of the Fourth Amended and Restated Intervenor Funding Agreement ("IFA") approved by the Oregon Public Utility Commission ("Commission") in Order No. 18-017 (January 17, 2018).

AWEC meets all of the criteria for payment of a Preauthorized Matching Fund Grant from the Avista Preauthorized Matching Fund Account for 2021, as demonstrated by the following:

- 1. Under the Amended IFA, Avista makes available an Annual Grant Amount of \$41,468.99, which is added to Avista's Preauthorized Matching Fund Account each calendar year during the term of the Amended IFA. IFA at Section 4.2.
- 2. A Preauthorized Matching Fund Grant from Avista must be used solely to pay Eligible Expenses for Eligible Proceedings involving Avista. IFA at Section 4.2.2. AWEC requests the payment of a Preauthorized Matching Fund Grant for Eligible Expenses incurred in Dockets UM 1929, UG 366 (Phase II), UG 392, UM 2121, and UM 2124 as Eligible Proceedings from October 1, 2020 through March 31, 2021. AWEC requests payment of the \$10,064.99 Preauthorized Matching Fund Grant for the expenses listed in confidential Exhibit A, attached, which are Eligible Expenses under Section 7.4 of the Amended IFA. These expenses are in excess of any amounts recovered through Issue Fund Grants and/or other Matching Fund Grant Requests.

- 3. A Preauthorized Matching Fund Grant may be provided only if AWEC demonstrates that it has used in-house resources or outside funding for at least 35% of the Eligible Expenses for Eligible Proceedings. Amended IFA at Section 7.2. As shown in confidential Exhibit A, AWEC has used in-house resources and outside funding for at least 35% of the Eligible Expenses in these proceedings.
- 4. AWEC is the successor to the Northwest Industrial Gas Users, which became precertified as eligible to receive intervenor funding grants under Section 5.2 of the original Intervenor Funding Agreement pursuant to Order No. 04-055, entered by the Commission on February 3, 2004. Under the current version of the IFA, funds from Avista's Preauthorized Matching Fund Account are available for use exclusively by AWEC. Amended IFA at Section 4.2.2.

Having demonstrated that it meets all of the criteria and conditions for such request, AWEC requests payment of a Preauthorized Matching Fund Grant from Avista's Preauthorized Matching Fund in the amount of \$10,064.99. AWEC requests that the Commission grant this request within 30 days of receipt and order Avista to pay AWEC the amount of \$10,064.99 within 30 days after receipt of the Commission directive, in accordance with Section 7.2 of the Amended IFA.

DISPOSITION: MATCHING GRANT REQUESTS APPROVED

On March 30, 2021, the Alliance of Western Energy Consumers (AWEC) filed a Request for Payment of a Preauthorized Matching Grant. Section 7.2 of the Fourth Amended and Restated Intervenor Funding Agreement (Agreement), adopted by the Commission in Order No. 18-017, governs the procedures for payment of Matching Fund Grants. Funds from the Avista Corporation, dba Avista Utilities Matching Fund; the Cascade Natural Gas Company Matching Fund, and the Northwest Natural Gas Company, dba NW Natural Matching Fund are available for use exclusively by AWEC. AWEC, as the Northwest Industrial Gas Users, was precertified to receive Matching Fund Grants on February 3, 2004, in Order No. 04-055.

AWEC asks for \$10,064.99 from the Avista Utilities Matching Fund Account, \$9,470.66 from the Cascade Natural Gas Matching Fund Account, and \$11,081.33 from NW Natural Preauthorized Matching Fund Account. Under the terms of the Agreement, AWEC must establish that it has used in-house resources or outside funding for at least 35 percent of the Eligible Expenses for an Eligible Proceeding. AWEC provided the required documentation in its request.

Section 7.7 of the Agreement provides that the Commission will make a determination in each proceeding as to how the participating utilities are to recover the funding grants from

the various customer classes. Section 7.7(b) of the Agreement provides that the Preauthorized Matching Grants are allocated and charged to industrial customers. The Commission finds that AWEC has met the requirements of the Agreement, and its request should be approved. Section 7.2 of the Agreement provides that the utility must pay the Preauthorized Matching Grant to the requesting intervenor within 30 days after receipt of the Commission directive.

ORDER

IT IS ORDERED that:

- 1. The Alliance of Western Energy Consumers has met the requirements of the Fourth Amended and Restated Intervenor Funding Agreement, and its requests are approved.
- 2. Avista Corporation, dba Avista Utilities pay \$10,064.99 from the Avista Utilities Preauthorized Matching Fund to the Alliance of Western Energy Consumers within 30 days after receipt of this order, and the grant is assessed to Avista Utilities' industrial customers.
- 3. Cascade Natural Gas Corporation pay \$9,740.66 from the Cascade Natural Gas Preauthorized Matching Fund to the Alliance of Western Energy Consumers within 30 days after receipt of this order, and the grant is assessed to Cascade Natural Gas's industrial customers.
- 4. Northwest Natural Gas Company, dba NW Natural, pay \$11,081.33 from the NW Natural Preauthorized Matching Fund to the Alliance of Western Energy Consumers within 30 days after receipt of this order, and the grant is assessed to NW Natural's industrial customers.
