Proposed changes are to add a Special Fuel Surcharge Supplement No. 1 in the amount of 3.47%.

3. The temporary 3.47% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of April 2022, May 2022 and June 2022, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of August 2022, September 2022 and October 2022

Customers who are billed bi-monthly for services – current month and one month in advance:

September 2022	September, October and November 2022
October 2022	October, November and December 2022
