RE: Docket UE-250617 - PacifiCorp's 2025 Clean Energy Implementation Plan

PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp) submits its 2025 Clean Energy Implementation Plan (CEIP) to the Washington Utilities and Transportation Commission in accordance with WAC 480-100-640.

The workpapers supporting the 2025 CEIP include highly confidential materials provided in accordance with WAC 480-07-160. These highly confidential materials are spreadsheets and data files containing highly confidential information as defined in WAC 480-07-160(2)(b), (d), RCW 80.04.095, and RCW 81.77.210.2 Specifically, the files contain competitively sensitive and proprietary information including contract pricing, detailed load forecasts, and detailed resource cost data and third-party proprietary modeling information. Disclosure of the information in these files would result in an unfair competitive disadvantage and result in financial harm to PacifiCorp. This financial harm will result from PacifiCorp's inability to negotiate lowest-cost pricing on behalf of its customers if its contractual counterparties are put on notice that pricing and contract terms will be disclosed in the public record. This financial harm would ultimately harm customers if PacifiCorp is required to incur greater costs associated with providing electric service.
