Dear Estates Water System Customer,

We recently mailed a notice regarding proposed new rates filed with the Utilities & Transportation Commission. It was brought to our attention that the meter sizes were not clearly labeled for your system, so we are sending this amended notice for clarification.

Your current tariff lists your meter size as 3/4", which is why it was listed that way on the "Current" rates in the notice. Your meter size is technically 5/8" x 3/4", so <u>all Estates residential customers will be</u> set to the proposed 5/8" rates, not the proposed 3/4" rates.

We have included a copy of your current rates below, with the correct 5/8" meter size, as well as a copy of the proposed rates on the back of this notice. A copy of the original notice is on our website; please let us know if you need an additional copy or have any questions.
