Re: Notice of Proposed Rate Changes

Dear Cascade Natural Gas Customer:

On March 24, 2022, Cascade Natural Gas Corporation ("Cascade") filed the Protected Plus Excess Deferred Income Tax ("EDIT") tariff revision with the Washington Utilities and Transportation Commission (WUTC) proposing an overall average 0.01 percent decrease for most austomer groups with natural gas service. The changes are proposed to become effective May 1, 2022. Distribution system transportation austomers (Schedule 663) will see a slight increase on their bill. If the WUTC approves the proposal, the total increase for Schedule 663 austomers using 285,214 therms per month will be 0.36 percent or \$39.93 more per month, bringing the total average monthly Cascade bill to \$11,176.21 from \$11,136.28. The average bill includes the monthly basic charge which has not changed with this filing. Current average rate, due to tiered rate structures based on individual austomer consumption, for Schedule 663 is \$0.06068 and the proposed rate change will increase the rate to \$0.06082.

Cascade makes the following filing to rectify a potential Internal Revenue Service normalization violation. This filing is intended to correct a potential normalization violation as it relates to the amortization of the EDIT.

The WUTC will review the filing and has the authority to set final rates that may vary from Cascade's requests, either higher or lower, depending on the results of its investigation.
