To whom it may concern:

Frontier Communications Northwest Inc. submits Advice No. 3307, a tariff filing in the General and Local Exchange Tariff, WN U-17.

The Washington Utilities and Transportation Commission approved the indirect transfer of control of Verizon Northwest, Inc. ("the Company") from Verizon Communications, Inc. ("Verizon") to Frontier Communications Corporation ("Frontier") in Docket UT-090842, Order 06. On July 1, 2010, the transaction was completed, and the Company filed articles of amendment to change its legal entity name from Verizon Northwest Inc. to Frontier Communications Northwest Inc. A copy of the Washington Secretary of State's certification of the filing is enclosed.

The purpose of this filing is to revise the Company's General and Local Exchange Tariff, WN U-17 to reflect the Company's new name and its affiliation with Frontier rather than Verizon. The revisions include the following administrative changes, which were shared with members of the Commission staff in advance of this filing:

- Verizon registered trademarks; service marks and specific product names have been replaced with Frontier product names.
- All tariff sheets have been renumbered to start with an original sheet number.
- Removed all existing explanation of symbols references on each tariff sheet.
- Removed all existing "Reserved for Future Use" placeholder sections in the tariff.
- Updated all table of contents sheets to reflect updated tariff sections and sheet numbers.

There are no changes to rates, terms and conditions; therefore cost support is not submitted.

Frontier requests an effective date of October 29, 2010 for this tariff filing.
