The purpose of this filing is to comply with the Commission's Order No. 12, Final Order Approving and Adopting Settlement Stipulations; Authorizing and Requiring Compliance Filing, in consolidated Docket Nos. UE-072300 and UG-072301 (the "Order"). The attached revised tariff sheets reflect the form and rates authorized in the Order.

As required by WAC 480-07-883(2) a copy of this filing has been served on each party to this proceeding.

The enclosed tariff sheets reflect issue dates of October 20, 2008, and effective dates of November 1, 2008, by authority of the Washington Utilities and Transportation Commission in Docket Nos. UE-072300 and UG-072301 (Consolidated).

Work papers that demonstrate the derivation of the rates proposed to be changed by the enclosed tariff sheets are attached herewith in electronic format. Work papers that demonstrated the revenue requirements were included in appendices incorporated into the Order. In accordance with the Order, the enclosed electric tariff filing is based on a revenue deficiency of \$130,179,688 or an increase in electric

rates of 7.1% and the natural gas tariff filing is based on a revenue deficiency of \$49,212,697 or an increase in natural gas rates of 4.2%.

Appendices A – C and Appendix E do not contain provisions that require tariff filings to be included in this compliance filing. Appendix D of the Order, the Partial Settlement Re: Service Quality, Billing and Metering Performance, and Low-Income Bill Assistance, was approved and adopted by the Order. That settlement reflected a number of changes in the Company's low income bill assistance programs, including increasing benefits and a change in the allocation of funds to the electric and gas programs. Those changes were incorporated in the Company's annual update filings of low income programs on August 28, 2008 in Docket Nos. UE-081577 and UG-081578 and will become effective coincident with this filing, on November 1, 2008, and are therefore not included in this filing. The overall low income program caps and other pertinent information are reflected in the tariff sheets included in those filings. Appendix D also provided for certain changes to the SQI program, one of which is an addition to the Service Guarantee that is reflected in the enclosed Schedule 131.
