TO ALL PARTIES:

The Commission entered its Order 12 Final Order Approving and Adopting Settlement Stipulations; and Authorizing and Requiring Compliance Filing in consolidated Dockets UE-072300 and UG-072301 on October 8, 2008. The order, among other things, rejected a tariff proposal by Puget Sound Energy (PSE), but authorized and required the Company to file tariff sheets consistent with terms of Order 12. The order also authorized the Commission's Executive Director and Secretary to approve the authorized filing by letter if it complied with the terms of the order.

On October 21, 2008, PSE filed tariff sheets as specified in the order. A list of the tariff sheets is attached to this letter. The Commission has examined the filing and it appears to comply with the terms of the order.
