Dear Mr. Danner:

Enclosed you will find the original and two copies of a Joint Motion to Amend Procedural Schedule and Certificate of Service. This Motion is being submitted by the Washington Independent Telecommunications Association (“WITA”), Inland Telephone Company (“Inland”) and Commission Staff. While the dates for the revised procedural schedule were agreed to among parties, including Intelligent Community Services, Inc. (“ICS”), it was subject to confirmation of witness availability. ICS has not been able to confirm with its witnesses that they are available on September 4, 2008. Counsel for ICS did not anticipate a problem with those dates, but needed to receive confirmation, which has not occurred to date.

Nevertheless, due to the fact that testimony from WITA, Inland and Commission Staff is due tomorrow, July 9, 2008, and in light of the discovery dispute which may affect the testimony, WITA, Inland and Commission Staff are going ahead with this Motion. The decision to move ahead was discussed with counsel for ICS through an exchange of voice mail messages. While ICS cannot at this time join in the Motion, ICS has no objection to WITA, Inland and Commission Staff proceeding with the Motion.


