Good Afternoon Judge Kopta – I am sending this after conferring with counsel for Staff and Public Counsel, and we are in agreement that it makes sense to preserve the procedural schedule in terms of existing deadlines and hearings, and this new schedule does that. In addition, while we have not seen Public Counsel's case in chief yet, it seems like we will be in full litigation mode with Public Counsel, so maintaining intervals that allow us to do discovery, etc, also makes sense. We did not see a realistic way to shorten the schedule.
