Pursuant to Order 2, paragraph 28 in Dockets UE-180607 and UG-180608, attached for filing is Puget Sound Energy's ("PSE") Final 2021 Integrated Resource Plan ("Final IRP"). The attached Final IRP, along with individual chapters, appendices and data files are posted at pse.com/irp and available for download.

The final electric and natural gas plans were developed, with stakeholder input, over the last eleven months. PSE believes that stakeholder input has improved the Final IRP.
