| | | I am writing to ask that you diligently consider the safety of pedestrians, bicyclists, and motorists as you review the Ride the Ducks application to operate in a residential Seattle neighborhood. As I'm sure you are aware, the Ride the Ducks amphibious vehicles are very wide and very tall. The driver, even if he/she is paying attention, cannot see people or vehicles that are below, to the side, and/or in front of the bow of the "boat". By the current plan, Duck vehicles will be crossing the busy Cheshiaud pedestrian walkway and bicycle path that the city recently rebuilt specifically for pedestrian and bicycle use. Persons using this pathway every day include most of the employees of the adjacent Puget Sound Blood Center as well as the nearby Fred Hutchinson Cancer Research Center. I also see FHCRC cancer patients walking to and from their appointments on this pathwaypeople who really aren't in any condition to be running out of the way. There is no crossing this pathway every 15 minutes, putting up a train crossing-style barricade isn't really practical—the barricade would be down virtually all of the time. If allowed to proceed, the current plan, the DuckBoats will come down Newton Avenue from Eastlake, a major north-south thoroughfare. Right now, cars park along one side of Newton, which leaves only one driving lane on this "two-way" street. It is tight for a single car to drive down this street next to the parked cars, and two cars cannot pass. A DuckBoats would be making their turns. (Again, remember the frequency will be every 15 minutes.) These military vehicles were not at all designed for operating in dense urban areas. I hope the UTC will carefully weigh the safety concerns of Seattle citizens against the interests of this commercial enterprise. Thank you for your consideration. |

| | | Recently, following the Aurora Bridge tragedy resulting in senseless death and widespread injury, Ride-the-Ducks themselves have voluntarily agreed to no longer drive on the Aurora Bridge because the bridge's narrowest lanes (at 9.5ft) were too narrow to be safe for the Duck boats. And yet, many of the city streets they drive on as part of their tour are narrower than that. If the Ducks themselves recognize Aurora Bridge lanes as too narrow to be safe, how can narrower city routes - - with the added complications of pedestrians, cyclists, parked cars not be seen as even more unsafe? If left unchecked, hundreds of daily pedestrians, cyclists, work commuters, and Seattle Parks visitors will be in jeopardy from the amphibious Duck vehicles driving along our narrow city streets with their reduced visibility, wide turns, and deadly, antiquated mass. In response to the UTC's findings, the City respectfully requests that Ride the Ducks' vehicles be prohibited from returning to service in the City of Seattle until the company's unsatisfactory safety rating is resolved and the City has had time to implement additional safety regulations or agreed upon conditions for Ride the Ducks to continue operations. |
| | | On September 24, 2015, a Ride the Ducks vehicle collided with a charter bus on the Aurora Bridge, tragically resulting in five deaths and numerous injuries. The UTC investigation found Ride the Ducks committed 442 avoidable violations of Washington's Vehicle and Driver Safety Code requirements, and resulted in a proposed unsatisfactory safety rating. Yet, despite these findings, Ride the Ducks' vehicles may be allowed to return to Seattle streets before these safety concerns are sufficiently addressed. These circumstances are cause for great concern for the residents of Seattle. |
| | | The Review notes that Ride the Ducks has announced its vehicles will no longer travel the Aurora Bridge, and that all future tours will include two employees: one driver and one narrator. However, neither of these announcements have been formalized by an enforceable regulation or agreement. Following the UTC's final determinations, on or after December 21, the City requests that it be |

| | Charles Wheeler Barbara | Web Phone | provided ample opportunity to comment upon and formalize Ride the Duck's commitments before the UTC would potentially allow such vehicles-with an unsatisfactory safety rating- back among drivers, cyclists and pedestrians on Seattle's streets. The City's request is further supported by the reality that Ducks' vehicles traveling on Seattle's Fremont Bridge, which been proposed to the UTC as an alternative route, would pose even greater safety risks to the public. The Fremont Bridge has the city's highest volumes of bicycle traffic and significantly higher pedestrian volumes than other alternative routes, accordingto the Seattle Department of Transportation. The inherent vulnerability of cyclists and pedestrians to serious or fatal vehicle collisions is only increased by the size, sight lines, and configuration of the Duck vehicles. Thus, the alternative route proposed by Ride the Ducks is unacceptable to the City of Seattle, which should be provided ample time to address this issue through legislation or agreement . State law requires the UTC implement the least restrictive reasonable means to protect the public with respect to the time and nature of the cessation of services. Here, where the City of Seattle and its residents are at risk of sharing the road with a company that has 442 avoidable safety violations, an unsatisfactory safety rating, and a proposed alternative route that poses significantly more risk than its previous route over the Aurora Bridge. The only reasonable action is to allow the City the opportunity to address these significant safety concerns. The City respectfully requests that the UTC not allow any Ride the Ducks vchicle to return to Seattle's streets until its unsatisfactory safety rating is resolved and Ride the Ducks commitments regarding alternative routes to the Aurora Bridge and distinct driver-narrator roles are reduced to legislation or an agreement. Finding a job at RTD has been the greatest blessing I could have ever received. It truly is a students dream to find a place to work that is so willing to work with you while you continue your education and to know that everyone is right behind you, cheering in your corner. After being laid off, I applied for unemployment benefits but was denied because, even though I can work 40 hours a week, I cannot do it within the state required time frame of Monday- Friday, from 8pm- 5pm.
