**Re: UE-210220 – Puget Sound Energy’s 2021 All-Source Request for Proposals - Power Purchase Agreement with Vantage Wind Energy LLC**

Dear Director Maxwell:

Pursuant to Washington Administrative Code (“WAC”) 480-107-035(7), Puget Sound Energy (“PSE”) hereby files with the Washington Utilities and Transportation Commission (“Commission”) the agreement executed with Vantage Wind Energy LLC (Vantage).<sup>1</sup> The agreement, which was executed on June 21, 2023, is the first agreement executed as a result of PSE’s 2021 All-Source Request for Proposals (2021 All-Source RFP).<sup>2</sup>

Under the provisions of WAC 480-07-160, PSE requests that this filing be accorded confidential treatment. Vendor specific information and other commercially sensitive financial data are included in the executed agreement and supporting materials. As required by WAC 480-07-160(3)(b)(i), PSE has properly identified all pages containing proprietary information.
