TO ALL INTERESTED PERSONS:

Pursuant to Order 2, paragraph 28 in Dockets UE-180607 and UG-180608, Puget Sound Energy (PSE or Company) filed its Final 2021 Integrated Resource Plan for electricity and natural gas service (Final IRP). Per [WAC 480-100-605](#), an “integrated resource plan” means an analysis describing the mix of generating resources, conservation, methods, technologies, and resources to integrate renewable resources and, where applicable, address overgeneration events, and efficiency resources that will meet current and projected needs at the lowest reasonable cost to the utility and its ratepayers and that complies with the requirements specified in [RCW 19.280.030\(1\)](#).

WRITTEN COMMENTS

The Washington Utilities and Transportation Commission (Commission) will accept comments on PSE’s Final IRP. Written comments on the Final IRP must be filed with the Commission no later than **5:00 p.m. on May 5, 2021**. The Commission requests that comments be provided in electronic format to enhance public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations from the comments.
