Dear Mr. Danner:

On April 16, 2010, the Washington State Utilities and Transportation Commission (“WUTC”) issued a Final Order Approving and Adopting, Subject to Conditions, Multiparty Settlement Agreements and Authorizing Transaction (“Approval Order”). In the Settlement Agreement with Staff of the WUTC (“Staff”), Frontier Communications Northwest (“Frontier”) agreed to submit an initial plan for broadband deployment and to consult with Staff regarding the geographic scope and timelines for implementation (Settlement paragraph 17). Frontier met with and consulted with Staff on September 23, 2010 regarding its broadband deployment and submitted its broadband deployment plan to the WUTC records center on September 28, 2010. On October 11, 2010 distribution of the broadband deployment plan was made to the service list in the docket with attachments labeled Highly Confidential and included a Public Redacted version. This mailing is being distributed to an amended service list in the docket and contains the same broadband deployment plan distributed on October 11, 2010. The attachments are marked as Highly Confidential and Proprietary information. Frontier has filed both a Highly Confidential and a Public redacted version in accordance with the Protective Order in the above-referenced docket.


