Q3 2024 Quarterly PCAM Report (January 2024 through September 2024)**

PacifiCorp dba Pacific Power and Light Company (PacifiCorp or Company) submits its Q3 2024 Power Cost Adjustment Mechanism (PCAM) quarterly report in accordance with Order 01 in Docket UE-210447 dated September 30, 2021. Specifically, Ordering Paragraph 3 requires PacifiCorp to “provide quarterly reports on PacifiCorp d/b/a Pacific Power & Light Company’s PCAM deferral balance beginning December 15, 2021”.

The allocation factors used in this Q3 2024 report for calendar year 2024 are preliminary, subject to change, and are currently based on the 12 months ended September 2024. Allocation factors for calendar year 2024 have not yet been finalized. The Company’s annual PCAM filing for calendar year 2024, due to be filed with the Washington Utilities and Transportation Commission in June 2025, will reflect final calendar year 2024 allocation factors.

Confidential work papers are provided in accordance with WAC 480-07-160. The confidential work papers include valuable commercial information, specifically confidential cost and financial information associated with loads and pricing. Disclosure of such information would harm PacifiCorp by an unfair competitive disadvantage.
