2		
3	Q.	Please state your name and business address.
4	A.	My name is Michael Dotson. My office address is 1300 South Evergreen Park Drive
5		Southwest, P.O. Box 47250, Olympia, Washington, 98504. My email address is
6		michael.dotson@utc.wa.gov.

8	Q.	By whom are you employed and in what capacity?
9	A.	I am employed by the Washington Utilities and Transportation Commission
10		(Commission) as a transportation specialist in the Licensing Services section.
11		
12	Q.	How long have you been employed by the Commission?
13	A.	I have been employed with the Commission since February, 2013.
14		
15	Q.	What are your duties as a transportation specialist?
16	A.	As relevant here, I review and process all applications for operating authority made
17		by persons seeking a household goods carrier permit.
18		
19	Q.	Have you received any training or education to help you carry out your duties
20		as a transportation specialist?
21	A.	Yes. I was trained by the employee that held my position prior to me.

1	Q.	Have you previously testified before the Commission?
2	А.	Yes.

4		II. SCOPE AND SUMMARY OF TESTIMONY
5		
6	Q.	What topics will you be discussing in your testimony?
7	A.	My testimony concerns whether the Comission will grant any type of household
8		goods permit to an applicant that it finds unfit to possess operating authority.
9		
10		III. UNFITNESS AND PROVISIONAL AUTHORITY
11		
12	Q.	When the Commission determines that an applicant for operating authority is
13		unfit, does the Commission grant the applicant any type of authority?
14	A.	No. The Commission does not grant any kind of authority to a company it finds
15		unfit.
16		
17	Q.	To be clear, that means that the Commission does not even grant an unfit
18		applicant provisional household goods operating authority?
19	А.	Correct.
20		
21	Q.	Can you explain why not?
22	А.	Provisional authority, in the case of a household goods moving company, grants the
23		applicant the full ability to operate in Washington state. If the Commission finds a

1	company unfit to hold operating authority, granting it provisional authority would
2	put the public at an equal amount of risk as if the Commission granted it immediate
3	permanent authority. The reason the Commission determines whether an applicant is
4	fit to operate prior to issuing provisional authority is to decide if the company can
5	operate in Washington state at all.
