- NATURE OF PROCEEDING. Docket UT-073034 originally involved a petition by Qwest Corporation (Qwest) and four (4) competitive local exchange carriers (CLECs)¹ seeking approval of a stipulation modifying various Performance Indicator Definitions (PIDs) as well as the Qwest Performance Assurance Plan (QPAP), each of which is an exhibit to Qwest's Statement of Generally Available Terms (SGAT). Qwest filed the stipulation and is pursuing the same action before 13 other state commissions.
- October 18, 2007, Qwest filed a Motion to Convert Proceeding to a Six-Month Review and to Vacate the Current Schedule. Qwest's motion indicated that all CLEC parties in the case did not object to its request. On October 24, 2007, Commission Staff filed its Response to Qwest's Motion indicating no objection to the request. Therefore, on October 25, 2007, the Commission entered Order 04, converting the docket to a six-month review proceeding as contemplated by Section 16.1 of the QPAP and vacating the previously established procedural schedule in this docket.

Order 04 also scheduled a prehearing conference to determine a new schedule.

CONVERSION OF PROCEEDING TO A SIX-MONTH REVIEW. On

CONFERENCE. The Washington Utilities and Transportation Commission (Commission) convened a prehearing conference in this docket at Olympia, Washington, on November 8, 2007, before Administrative Law Judge (ALJ) Adam E. Torem.

- APPEARANCES. Lisa A. Anderl, Associate General Counsel, Seattle, Washington, represents Qwest. Ginny Zeller, Associate General Counsel, Minneapolis Minnesota, represents Integra Telecom of Washington, Inc. (Integra), and Eschelon Telecom, Inc., (Eschelon). Gregory J. Kopta, Davis Wright Tremaine LLP, Seattle, Washington, represents Time Warner Telecom of Washington, LLC. (Time Warner), and XO Communications Services, Inc. (XO). Jonathan Thompson, Assistant Attorney General, Olympia, Washington, represents the Commission's regulatory staff ("Commission Staff" or "Staff"). Contact information for all parties' representatives is attached as Appendix A to this order.
- NOTICE OF RIGHT TO PARTICIPATE IN SIX-MONTH REVIEW. As required by due process and in accordance with the terms of Section 16.1 of the QPAP, this prehearing conference order is being served to all potentially interested Washington CLECs. Any Washington CLEC wishing to participate in the sixmonth review must file and serve a letter of intent to participate, a notice of appearance by its representative, and its preliminary list of issues to be discussed no later than Monday, December 10, 2007.
- ISSUES LIST. Qwest's original petition in this docket proposed a number of modifications to its PIDs as well as to the QPAP. Commission Staff and the Intervenors filed comments raising additional issues to be resolved in this proceeding. In order to clarify the currently contemplated scope of the six-month review now being undertaken, Commission Staff has compiled a preliminary issues list summarizing each issue already presented in this matter. A copy of this list is

REVISED PROCEDURAL SCHEDULE. The parties agreed during the conference to modify the procedural schedule for this proceeding. - **DOCUMENT PREPARATION AND FILING REQUIREMENTS.** Parties must file an original plus **five (5) paper copies** of all pleadings, motions, briefs, and other prefiled materials. These materials must conform to the format and publication guidelines in WAC 480-07-395 and WAC 480-07-460. The Commission prefers that materials be three-hole punched with *oversized* holes to allow easy handling. The Commission may require a party to refile any document that fails to conform to these standards.
- All filings must be mailed or delivered to the Executive Secretary, Washington Utilities and Transportation Commission, P.O. Box 47250, 1300 S. Evergreen Park

Drive, S.W. Olympia, Washington 98504-7250. Both the post office box and street address are required to expedite deliveries by the U.S. Postal Service.

- An electronic copy of all filings must be provided either through the Commission's Web Portal (www.utc.wa.gov/e-filing) or by e-mail delivery to records@utc.wa.gov. Alternatively, parties may furnish an electronic copy by delivering with each filing a 3.5-inch IBM-formatted high-density diskette or CD including the filed document(s). Parties must furnish electronic copies in MS Word 6.0 (or later) supplemented by a separate file in .pdf (Adobe Acrobat) format. Parties must follow WAC 480-07-140(5) in organizing and identifying electronic files.
- 11 ELECTRONIC SUBMISSION OF DOCUMENTS. Pursuant to WAC 480-07-145(6), the presiding officer grants a one-day extension of the paper-filing requirement, allowing electronic submission of documents with the Commission on the filing deadline. Parties must submit documents either through the Commission's Web Portal (www.utc.wa.gov/e-filing) or by e-mail to records@utc.wa.gov, and file an original, plus five (5) paper copies, of the documents with the Commission by noon on the following business day. Parties must provide courtesy copies of their electronic submissions to the presiding administrative law judge and the parties to the proceeding.
- NOTICE TO PARTIES: Any objection to the provisions of this Order must be filed within ten (10) days after the service date of this Order, pursuant to WAC 480-07-430 and WAC 480-07-810. Absent such objection, this Order will control further proceedings in this matter, subject to Commission review.

Preliminary Issues List UT-073034

The following issues are raised by the stipulation between Qwest Corporation, Eschelon Telecom, Inc., DIECA Communications, Inc. d/b/a Covad Communications Company, and McLeodUSA Telecommunications Services, Inc. on June 26, 2007, in Docket UT-073034.

ISDN BRI (designed)		Update the PID references to unbundled 2-wire non-loaded loop and unbundled ISDN capable loop disaggregations to reflect the retail analogue of "ISDN BRI (designed)."
Reinstatement/Removal		Remove the PIDs specified in the 2007 Stipulation from PAP payment mechanisms to the extent they currently are included in a specific state's PAP, subject to a Reinstatement/Removal process. Also, add a root cause analysis provision.
One-hour exclusion	MR-6	Add exclusion to MR-6 PID that allows No Trouble Found (NTF) and Test Okay (TOK) trouble reports to be removed when the ticket's duration is one hour or less.
UNE billing accuracy	BI-3A	Change the standard for BI-3A PID to a 98% benchmark and add a provision to the PAP for the BI-3A PAP payment calculation, creating a tiered structure of per occurrence amounts and modifying the per measurement cap for the sub-measure.
One Allowable Miss		Add one allowable miss provision to the PAP for individual CLEC results when the CLEC aggregate results have met the standard.

Tiered Minimums		Revise the PAP to change the flat minimum payment amounts of \$300/\$600 (MN) and \$2000 (the remaining states, including Washington) with a tiered minimum payment approach that establishes a relationship between the monthly PAP payment and the required minimum payment amount.
Low-volume services		Remove the following list of product disaggregations from all applicable OP and MR PIDs in the 13 state PAPs: Resale Centrex, Resale Centrex 21, Resale DS0, E911/911 Trunks, Resale Frame Relay, Resale Basic ISDN, Resale Primary ISDN, Resale PBX, Sub-loop Unbundling, UNE-P POTS, UNE-P Centrex and UNE-P Centrex 21.

LNP Name change	MR-11	Change the MR-11 PID title to "LNP Trouble Reports Cleared within Specified Timeframes."
