The final report and the Interim Remedial Action Report should be completed later this fall.

CHEHALIS, WASHINGTON

Monitoring wells have been installed to assess any impact site contamination might have had on ground water. Results of the analysis of the ground water samples are expected later this fall and they will determine in part what, if any, further remedial activity is necessitated at the site.

The purpose of this memorandum is to document the acceptance by the U.S. Environmental Protection Agency (EPA) of the "Sept. 1995 Remedial Action Report" submitted by Matt Dalton on Behalf of the Washington Natural Gas Company. This report details the site history, site description, describes the remedial action, provides construction QA/QC and most importantly certified the completion of the remedial construction activities required by the Consent Decree lodged October 4, 1991 which implemented the Record of Decision signed December 30, 1987.

The remedial construction actions consisted of excavation of most of the site to a minimum depth of 3 feet to capture and stabilize lead, benzene, pah's and PCB's. In some locations excavation was much deeper to capture and stabilize tarry material identified as extremely hazardous waste (EHW). This action included excavation of the tar ponds (north and south), the Tar Pit, the Joseph Simon & Sons operating property, and peripheral area hot spots.

The excavated material was segregated and stabilized using specific mixes for each category of waste type. The stabilized products were placed in the "Waste pile" in an area that included the remediated north and south ponds. As required by the ROD other construction activities included placement of a site drainage system. Two separate systems were constructed, one for the waste pile area and another for the Simon & Son property. The last major component of the remedy was placement of a low permeability cover over the site. A combination of cover materials were used throughout the site. Each cover system was designed to meet the EPA permeability requirement and to accommodate the appropriate future land use requirements. Therefore the covers on the site include a geosynthetic system on



the waste pile and low permeability asphalt and a reinforced cement mixe on the operating area. The details, including the "as built" drawing are contained in the RAR.

Quarterly water quality monitoring will continue at the site to determine the need for groundwater remediation.

The information in the RAR states that the construction was completed per the ROD and the Consent Decree. Also the report indicates full performance of the RA and attainment of the performance standards.

EPA with its contractor CH2MHill provided oversight along with assistance from the Washington Department of Ecology. All parties have verified the completion of construction during the inspections on June 14, 1995 and July 26, 1995.

In accordance with EPA guidance, "procedures of completion and deletion of National Priorities List sites, EPA/5411G-89/002, dated 1989 and updated February 19, 1992,." your approval of the attached Remedial Action is requested.

Dear Michael:

Although we have verbally acknowledged your letter of August 22, this letter will formally address your August 22 correspondence with the descriptive heading of "Gas Works Park Clean Up."

Since receipt of your letter we again reviewed the potential for liability of the gas company, third parties and the City of Seattle for clean up at the site. We discussed and reviewed the litigation potentials of the situation again with counsel for our insurance carriers. We considered the prospect for third-party contribution and we reviewed the nature and scope of clean-up requirements through independent consultants and through direct inquiry to the Department of Ecology. We learned some facts during this process which may be helpful to both the gas company and to the City.

The most encouraging, perhaps, is the remediation cost estimate of our independent consultant, after discussions with the Department of Ecology. We are advised that remediation could perhaps be completed for less than \$2 million. This estimate supports an effective remediation plan, acceptable to DOE.

In your letter of August 22, you reiterate the City's view that WNG has "little or no chance of prevailing on its contract argument . ." Unfortunately, we may never agree on the contractual liability issues. Steve Secrist's memorandum, attached, addresses the contract language, its intent and the impact of liability imposed by CERCLA/MTCA. Steve reconfirmed our earlier conclusions with respect to the City's liability and the substantiality of the gas company's defenses.

Our intent, Michael, is not to argue our position here; but please know that neither the gas company nor our insurance carriers is capable of responding to the City's 80% contribution proposal.

Conversations with counsel for our insurance carriers remain inconclusive. Frankly, they are divided on whether or not to respond outside of a litigated proceeding.

The primary concerns of the insurance carriers are: (1) the ultimate dollar exposure and, (2) the nature and extent of the release from liability which would attend their participation in clean-up expenditures. Based on the review of our outside environmental consultant, I am less concerned with the ultimate dollar exposure for site remediation. The defense and indemnity requirements of the insurance carriers remain a substantial concern.

Any settlement would require a Consent Decree with a covenant from the City of Seattle and the Department of Ecology not to look to the gas company for any further contribution at the site. Even with such protections, additional risks remain for off-site migration issues.

The Consent Decree will not be able to address WNG's exposure to suits from third parties who may have contributed to the site, such as ATCO and Metro. We and our carriers will, presumably, have to negotiate some allocation of these risks. WNG will likely have to hold the insurers harmless for subsequent lawsuits from these third parties and from EPA action on the "uplands site."

We previously offered to participate at a level of 30% with a maximum contribution of \$3 million. As noted above, we have not been successful in getting our insurance carriers to accept that proposal. Nonetheless, I am willing to consider a settlement with the City in exchange for the Consent Decree protections noted above. We are also prepared to provide a maximum contribution by WNG and its carriers of 50% of site clean-up costs pursuant to the Department of Ecology remediation, or \$5 million, whichever is less. If we are forced to respond to litigation, our tender for settlement in such amount would put the City at risk for our litigation costs in expensive and protracted litigation involving many parties with diverse interests.

Like you, I hope we can reach agreement. We do not have concurrence among our insurance carriers that they would participate with us in such a contribution level. They may not do so. WNG is accepting that risk. This represents our best effort to respond.

Washington Natural Gas Company (WNG) submits the following quarterly update reflecting a) the status of various remediation projects, b) costs incurred through September 30, 1996 and c) the status of legal proceedings related to any of these sites.

1. <u>22nd and "A" Street, Tacoma, Washington Site</u> (Upland Source Control)

Black & Veatch Consultants working on behalf of the potentially liable parties (PLPs) submitted the Draft Technical Memorandum Pre-Remedial Design Report for Interim Source Control to WSDOE.

Currently, the PLPs are working on a cost-sharing arrangement for the scope of work necessary to proceed with the project. Individual tasks include regulatory negotiations, alternative selection, documentation, and remedial design.

Total remedial costs spent this quarter -0-. Total spent to date \$25,146.00.

2. WSDOT v. WNG (State)

Although this matter has been completed, it is included in this update because WNG sought attorneys' fees as the prevailing party in this action and successfully recovered the sum of \$25,835.27.

3. Thea Foss Waterway

Based upon EPA revisions, revised sections of the Round Two Data Evaluation Report were submitted to the EPA. The City has also begun work on the Round Three sampling and analysis plan. The City of Tacoma has also begun work on the development of the screening of Remedial Options Report which will target proposed remedial alternatives for the Thea Foss Waterway together with a estimate of the associated costs.

To date, the City estimates that approximately 64% of the remedial design work is completed.

Total remedial costs spent this quarter \$4,942.00. Total spent to date \$42,747.00.

4. Everett, Washington

WNG is continuing to collect and analyze data from this site to assist in the development of a Cleanup Action Plan. Because WSDOE has encouraged WNG to proceed with an independent action, WNG will undertake the preparation of this report for submittal to WSDOE sometime in January, 1997.

Total remediation costs spent this quarter \$2,710.00. Total remedial costs spent to date \$462,940.00.

5. Chehalis, Washington

WNG continues to collect groundwater samples and analyze these to assess the effectiveness of the source removal that was performed in 1994-1995 and will continue to perform this function through at least December 1996.

Total remedial costs spent this quarter \$22.00. Total remedial costs to date \$1,717,177.00.

6. Gas Works Park

WNG and the City of Seattle are negotiating an agreed order with WSDOE which would advance the remediation project through preparation of a Cleanup Action Plan. In the course of these discussions, the parties are also developing a scope of work for the tasks to be performed prior to and as part of the Cleanup Action Plan and a schedule for the timing of these activities.

WNG and the City are also continuing to meet and discuss an equitable resolution to the division of costs that will be incurred over the course of the Cleanup Action Plan and implementation of the remediation design.

Total remedial costs spent to date: \$45,651.38 (WNG inadvertently reported costs associated with this site which included costs for outside counsel. These costs have been backed out leaving the aforementioned total remedial costs provided in accordance with the November 25, 1992 WNG remediation program letter from the WUTC).

7. Tulalip Landfill

WNG has now executed the De Minimum Settlement which includes an amount for Natural Resources Damages thereby concluding this matter. No further updates will be provided.

Total remedial costs spent this quarter \$11,070.00. Total remedial costs to date \$11,328.00.

Washington Natural Gas Company, now Puget Sound Energy, Inc. (PSE), submits the following quarterly update reflecting a) the status of various remediation projects, b) costs incurred through December 31, 1996 and c) the status of any legal proceedings related to y these sites.

1. 22nd and "A" Street, Tacoma, Washington Site (Upland Source Control)

The Potentially Liable Parties (PLPs) have negotiated a Second Addendum to the Funding and Participation Agreement under which Black & Veatch Consultants, Inc. will proceed with their analysis of source loading to the Thea Foss, further scoping of contaminants, and pre-remedial design.

Total remedial costs spent this quarter \$35,138.78. Total spent to date \$61,757.85.

2. Thea Foss Waterway

The City of Tacoma has completed its screening of Remedial Options Report for the Thea Foss and Wheeler Osgood Waterways. This report screens seven proposed alternatives for the remedial efforts at the Thea Foss Waterway and identifies three options which it proposes to carry forward for further analysis. The cost of the three alternatives range from \$11,000,000.00 to \$14,500,000.00. Of the three alternatives, the City of Tacoma has identified alternative No. 4 as the preferred proposal (costing \$11,280,000.00). This proposal would combine natural recovery, dredging of the mouth of the Wheeler Osgood and midpoint of the Thea Foss, a thick cap between S. 15th Street and E. 19th Street, and a Confined Aquatic Disposal Site (CAD) at the head of the Thea Foss Waterway.

The justifications for alternative No. 4 include the following:

- It is a permanent long-term solution that is consistent with the ARARs and is protective of human health and the environment.
- The construction of the CAD site provides an increase in the habitat area over the other alternatives.
- Of the available alternatives, alternative No. 4 poses one of the lowest risks of exposure to workers and the general public.
- The CAD site caps existing contamination at the head of the waterway and is closely situated to dredging activities.
- It is one of the least expensive viable alternatives.

The City is now working in round three performing analysis and data collection which will include a careful study of possible recontamination and source loading of contaminants at the head of the Thea Foss Waterway.

Total remedial costs spent this quarter \$8,621.63. Total spent to date \$51,368.18.

3. Everett, Washington

PSE has completed a draft of the Clean-up Action Plan and, upon completion, will proceed with the pre-remedial design which proposes a containment system with limited hot spot removal and groundwater treatment.

Total remediation costs spent this quarter \$4,310.84. Total remedial costs spent to date \$467,250.34.

4. Chehalis, Washington

PSE is continuing to monitor the groundwater at this site to assess the effectiveness of the source removal measures that were undertaken.

Total remedial costs spent this quarter \$4,583.70. Total remedial costs to date \$1,721,760.58.

5. Gas Works Park

A Public Participation Plan was prepared to facilitate an opportunity for the public to comment on the data and reporting completed by PSE and The City of Seattle. The Public Participation Plan includes hearings at which the public can hear presentations regarding the preferred remedial option and data compiled to date and have an opportunity to present their opinions. There is also an opportunity for written opinions which can be submitted to either of the parties or WSDOE. Upon completion of the Public Participation phase, all comments received will be reviewed by the parties and, where appropriate, responses will be provided and/or the input may be incorporated into the remedial plans.

The next phase of the Public Participation Plan will include site tours which will be hosted by the parties and WSDOE and include a greater opportunity for the public to understand the nature of the environmental issues at Gas Works Park and the parties' plans for addressing these.



Dear Mr. McClellan:

The following report is submitted for quarterly activity at sites where significant remedial activity is either underway or planned. Each of these sites was either formerly used for manufactured gas plant facilities or alleged to be contaminated from former manufactured gas plant (MGP) operations.

1. Tacoma Gas Company Site (Upland Source Control):

Black & Veatch Consultants (B&V) are continuing to develop modeling to demonstrate what, if any, contaminants from this site may be an ongoing source of contamination to the Thea Foss waterway. The results of this modeling are not expected to be completed until approximately September 1997 and may have a significant bearing upon any future remedial activity, if any, at this site.

Total remedial costs spent this quarter \$157,031.23 Total spent to date \$218,789.08

2. Thea Foss Waterway

The City of Tacoma, EPA, Department of Natural Resources, and the Army Corps of Engineers are evaluating and proposing modifications to the "Screening of Remedial Options Report" which was referenced in my March 28, 1997 letter. The currently favored remedial option still includes a combination of dredging, natural recovery, and capping. However, the appropriate mix of these three measures is still a subject of considerable debate. Sampling activity is planned for the summer of 1997 to further identify remedial hot spots within the Thea Foss and allow the City of Tacoma to provide greater specificity to the planned remedial options.

3. Everett, Washington

PSE is in the process of accumulating data for the pre-remedial design phase of this project. The currently anticipated remedial design includes a containment system, hot spot removal, and possible groundwater treatment.

The following report is submitted in accordance with the above-referenced docket numbers to update the WUTC on environmental matters undertaken by Puget Sound Energy. Please note that for ease of communication, this report will combine remedial activity for both the former Puget Sound Power & Light and the former Washington Natural Gas Company. However, to assist your review, I will segregate this report into the following two headings: Former WNG sites and Former Puget Power sites.

Should you have any questions or comments regarding this new format, please let me know. Otherwise, all future updates will be provided in a similar fashion.

1. FORMER WNG SITES

A. Tacoma Gas Company Site (Upland Source Control)

Recontamination modeling is under development for the site to assist in the determination if any contamination from this property is an ongoing source of contamination to the Thea Foss Waterway. PSE's consultant, Black & Veatch, is performing this work and anticipates results by the end of December 1997. At that time, PSE and the other potentially liable parties (PLPs) will be able to commence negotiations with Washington State Department of Ecology (WDOE) to determine the appropriate remedial activity for the site, if any.

B. Thea Foss Waterway

The City of Tacoma, as the lead PRP for this project, is preparing a new proposed remedial option report. In its final form, it is anticipated that the City will propose a remedial option which combines dredging, natural recovery, and capping.

C. Everett, Washington

PSE has submitted permit applications for the containment wall it has proposed as the appropriate remedial option for this site. Final permits are expected by the end of December 1997 and implementation of remediation is tentatively scheduled for Spring of 1998.

D. Chehalis, Washington - Gas Site

PSE continues to collect groundwater monitoring data to assess whether any additional remedial activity is required at this site.

E. Gas Works Park

PSE and the City of Seattle have completed negotiations on a budget for a focused feasibility study and have retained Parametrix for this phase of the project. It is currently projected that this study will be completed in Fall 1998.

2. FORMER PUGET POWER SITES

A. Northwest Transformer, Mission Pole

PSE is currently awaiting response from EPA concerning ground water monitoring which is expected in the first quarter of 1998.

B. Northwest Transformer, South Harkness

EPA has deleted the site from the Federal NPL because of reduced risk to the public following completion of 1996 groundwater monitoring review. The site was delisted September 1998.

C. Coal Creek

There has been no change at this site and it is not currently anticipated that PSE will incur any future costs at this site. Therefore, no further updates will be provided regarding the site unless the situation changes.

3. UNDERGROUND STORAGE TANKS

The attached spreadsheet shows current and projected activity for PSE USTs. Current projections for remedial costs associated with USTs are \$1.1 million, but could change depending upon the level and impact of contamination found.
