First Supplemental Order Approving in Part and Rejecting in Part

Settlement Agreement

On May 22, 2002, in Docket UT-010161, the Commission issued its First Supplemental Order Approving in Part and Rejecting in Part Settlement Agreement for New Access Communications, LLC (New Access). In the order, the Commission directed Staff to file a report showing which customers of New Access received refunds, how much each received, and whether all customers eligible for refunds received them.

On September 5, 2002, New Access provided evidence to Staff that it has issued refunds and/or credits to each customer with a slamming complaint who was eligible for a refund and had not previously received one¹. The company refunded or credited a total of \$6,310.58 to thirty-seven complainants. A chart showing refund/credit amounts is attached.

New Access has also provided evidence that on July 31, 2002, it issued refunds to all customers billed rates and charges that were not in the company's approved price list on file with the Commission at the time of the billing. The total refund amount for 4,705 customers is \$14,361.71. The company's documentation that illustrates it made all 4,705 refunds is available at your request.

Staff believes that New Access has complied with the Settlement Agreement and the Commission's order. Staff is available to answer any questions you may have.
