- I On July 6, 2001, in Docket No. UT-010988, Bernice Brannan and twenty-six other named individuals filed with the Commission a complaint against Qwest Corporation. The complainants request that the Commission remove the Lummi Business Utility tax from the tariff of Qwest Corporation to the extent the tax is passed through to non-tribal members located on fee land within the Lummi Reservation.
- 2 On July 6, 2001, in Docket No. TG-010989, Bernice Brannan and twenty-six other named individuals filed with the Commission a complaint against Sanitary Service Company, Inc. The complainants request that the Commission remove the Lummi Business Utility tax from the tariff of Sanitary Service Company, Inc., to the extent the tax is passed through to non-tribal members located on fee land within the Lummi Reservation.
- On July 6, 2001, in Docket No. UE-010990, Bernice Brannan and twenty-six other named individuals filed with the Commission a complaint against Puget Sound Energy, Inc. The complainants request that the Commission remove the Lummi Business Utility tax from the tariff of Puget Sound Energy, Inc., to the extent the tax is passed through to non-tribal members located on fee land within the Lummi Reservation.
- 4 On July 9, 2001, in Docket No. UE-010995, Terry McNeil and twenty-seven other named individuals filed with the Commission a complaint against Puget Sound Energy, Inc. The complainants request that the Commission remove the Swinomish Utility Business Activity tax from the tariff of Puget Sound Energy, Inc., to the extent the tax is passed through to non-tribal members located on fee land within the Swinomish Reservation.
- 5 On July 9, 2001, in Docket No. UT-010996, Terry McNeil and twenty-seven other named individuals filed with the Commission a complaint against Verizon Northwest, Inc. The complainants request that the Commission remove the Swinomish Utility Business Activity tax from the tariff of Verizon Northwest, Inc., to the extent the tax is passed through to non-tribal members located on fee land within the Swinomish Reservation.
- 6 The complaints are available for inspection at the Commission's office located at Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington. It is appropriate that the matters raised in the pleadings be brought for hearing before the Commission.
- 7 The foregoing complaints involve common questions of fact and law. Accordingly, the Commission has determined that they should be consolidated for hearing and determination. Pursuant to WAC 480-09-610, the disposition of the consolidation of these proceedings has been referred to the Administrative Law Judge assigned to these proceedings.

ORDER OF CONSOLIDATION

8 IT IS HEREBY ORDERED That each of the dockets listed above be and the same are consolidated for hearing and determination, with the Commission reserving the right to hold such separate hearings and to issue separate orders in the individual dockets as it may deem appropriate.

NOTICE OF PREHEARING CONFERENCE (October 22, 2001)

- Hearing in this matter is being held pursuant to Part IV of chapter 34.05 RCW pertaining 9 to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.431, RCW 34.05.440, RCW 34.05.443, RCW 34.05.449, RCW 34.05.452, and RCW 34.05.455. The Commission may have jurisdiction over this matter under Title 80 RCW, in connection with its legal authority to regulate the rates, services, and practices of telecommunications companies and electric utilities providing service within the state of Washington, and under Title 81 RCW having legal authority to regulate the rates, services, and practices of solid waste collection companies pursuant to chapter 81.77 RCW. The Commission's jurisdiction to hear the matter raised by Complainants, however, has been challenged by Verizon Northwest, Inc., Qwest Corporation, and Sanitary Service Company, Inc., in their Answers. The complainants cite Atkinson Trading Company, Inc. v. Shirley, et al., 532 U.S. (2001) and Big Horn Electric Coop., Inc. v. Adams, 219 F.3d 944 (9th Cir. 2000) in support of the allegations contained in their complaints. The statutes and rules involved may include those within chapter 80.04 RCW, chapter 80.28 RCW, chapter 80.36 RCW, chapter 81.04 RCW, chapter 81.28 RCW, chapter 480-09 WAC, chapter 480-70 WAC, chapter 480-100 WAC, and chapter 480-120 WAC. The issues involved are generally stated above and more specifically contained in the complaints.
- 10 NOTICE IS GIVEN That a prehearing conference in this matter will be held on Monday, October 22, 2001, at 2:00 p.m., in the Commission's Hearing Room, Second Floor, Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.
- 11 To assist the Commission in addressing these complaints, <u>all parties</u> are required to submit by Monday, September 17, 2001, a legal memorandum in support of their position as to whether the Commission has jurisdiction over these complaints. Responses to the parties' legal memoranda will be due Monday, October 1, 2001.
- 12 The purpose of the prehearing conference is to consider formulating the issues in the proceeding, and to determine other matters to aid in its disposition, as specified in WAC 480-09-460. Petitions to intervene must be made in writing prior to the prehearing conference. The time and place for any evidentiary hearing will be set at the prehearing conference or by later written notice. Appearances will be taken.
