- On May 29, 2003, Ed's Disposal, Inc. filed an application (No. GA-079175) for an extension of Certificate No. G-110 for a Certificate of Public Convenience and Necessity to Operate Motor Vehicles in Furnishing Solid Waste Collection Service in that portion of Benton County (Application). Notice of the Application was published in the Commission's weekly Docket of July 7, 2003.

    - c. Section 5, T10N, R26E
  - 2. The territory wholly contained within T10N, R27E, and T10N, R28E, and more specifically bounded as follows:
    - a. On the north by the US DOE Hanford Site:
    - b. On the east by the city limits of Richland (also the Horn Rapids Ditch)
    - c. On the west by the west line of R27E; and
    - d. On the south by the Yakima River

The Commission received no protests within the 20 days required by WAC 480-30-032(1). RCW 81.68.040 requires that the Commission grant authority in a territory already served only after hearing.
