TO INTERESTED PERSONS:

On January 27, 2004, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider possible corrections and changes to a rule in Chapter 480-122 WAC, Washington Telephone Assistance Program, relating to telecommunications. The CR-101, as filed with the Code Reviser, is available for inspection on the Commission's web site at www.wutc.wa.gov/040015. If you are unable to access the Commission's web page and would like a copy of the CR-101 mailed to you, please contact the Records Center at (360) 664-1234.

The Commission recently filed a CR-101 in this docket on January 21, 2004, at WSR# 04-03-118, and failed to list Chapter 480-122 WAC, as a chapter with a possible rule change. The two CR-101's will be joined for purposes of discussion and the drafting of a CR-102 proposal.

A rule provision identified for possible change is:

- Washington telephone assistance program rate (WAC 480-122-020)
