Amendment Number: 1

Description of amendment: This agreement is amended with terms, conditions and rates as set forth in Attachment 1 to this amendment, Intercarrier Compensation for ISP-Bound Traffic.

The amendment amends the interconnection agreement first accepted by the Commission on September 8, 2004 in WUTC Docket No. UT-043081 between Qwest Corporation and Universal Telecom, Inc. That agreement was originally approved by the Commission on April 6, 2003 in WUTC Docket No. UT-023042 between Level 3 Communications, LLC and Qwest Corporation.




WASHINGTON UTILITIES AND TRANSPORTATION COMMISSION

- (3) The laws and regulations of the State of Washington and Commission Orders govern the construction and interpretation of the Amended Agreement. The Amended Agreement is subject to the jurisdiction of the Commission.

The Commissioners, having reviewed the information available in this matter and having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
