BACKGROUND			
On January 19, 2006, the City of Sultan (city) filed an application with the Washington Utilities and Transportation Commission (Commission) requesting disbursement of \$20,000 from the GCPF to pay for a project related to crossing safety. The city planned to upgrade the BNSF Railway crossing at Foundry Road in Sultan, Washington. On August 16, 2006, the Commission approved this filing and required the city to complete the work by June 30, 2007. On March 28, 2007, the city contacted the Commission by electronic mail and explained the developer they contracted with to perform the work delayed the project and it would not start or finish the project by June 30, 2007.
