PASSENGER RULES AND REGULATIONS

One-Way Fares: All fares are published for one-way travel. Riders must have exact change.

Adult Fares: Fares published are adult fares and apply to passengers who have reached or passed their 6th (sixth) birthday.

Children’s Fares: Children 5 (five) years of age or under, when accompanied by an adult passenger and not occupying a seat will be carried free of charge. Children 6-12 (six to twelve) years of age and occupying a seat shall be charged one-half the adult rate.

Intermediate Application: Fares to or from intermediate points not named herein, will be the same as the fare to or from the next more distant station for which fares are named.

Scheduled Maintenance: Carrier will not be liable for delays caused by accidents, breakdowns, poor road conditions, snow storms or other conditions beyond his control and does not guarantee to arrive at, or depart from any point at any specific time. The time of arrival at and departure from any point as shown in its published time schedules are schedules it endeavors to maintain, but is not guaranteed.

Refunds: Does not apply because passengers do not purchase tickets until they board the bus.

Objectionable Passengers: Carrier reserves the right to refuse to transport persons under the influence of drugs or liquor, or incapable of taking care of themselves, or who’s condition, conduct or behavior may be objectionable to other passengers. The carrier reserves the right to refuse carriage of any materials that the carrier considers unsafe or not in the best interest of the passengers.

Baggage Rules: All baggage to be transported must be carried by the passenger and must not occupy a seat or prohibit safe movement up and down the aisle.

Animals: Dogs, cats and other animals or birds will not be carried. Exception: Service animals will be carried free of charge. The service animals will not be permitted to occupy a seat but must lie or stand at the feet of the passenger.

Bicycles: Bicycles will be carried subject to space availability at the rate of \$1.00 per bicycle.

Space Availability: All seats are sold on a “space available’ basis. The carrier makes no guarantees regarding availability of seating at any given time.
