- Note 2: Rates named in this item apply for all hauls not exceeding 10 miles from the point of pickup to the disposal site. Excess miles will be charged for at \$2.05(A) per mile or fraction of a mile. Mileage charge is in addition to all regular charges.
- Note 3: Permanent Service:
 (1) Service is defined as no less than scheduled, once a month pickup, unless local government requires more frequent service, or unless putrescibles are involved.
 (2) If a drop box is retained by a customer for a full month and no pickups are ordered, the monthly rent shall be charged, plus one service pickup charge will be assessed(N). Monthly rental charges will be prorated when a drop box is retained for only a portion of a month.
 (3) If rent is shown, the rate for the first pickup and each additional pickup must be the same. If rent is not shown, it is to be included in the rate for the first pickup.
