BETWEEN: <u>Whidbey Island and</u> Seattle Tacoma International Airport <u>via Deception Pass or the</u> <u>Clinton Ferry</u>; <u>Oak Harbor and Lupien Field</u>, <del>and Oak Harbor and the SeaTac International</del> <u>Airport via SR 20, SR 525</u>, the Clinton-Mukilteo Ferry, SR 525, SR 526, and Interstate 5. Door to door service in conjunction with the above route with pickup points on SR 20 and SR 525. <u>Closed door service between Clinton and SeaTac</u>.

<u>BETWEEN:</u> Oak Harbor and hotels and motels within a 1-mile radius and hotels and motels within a 1-mile radius of the SeaTac International Airport. via SR 20, SR 525, the Clinton-Mukilteo Ferry, SR 525, SR 526, and Interstate 5. Door to door service in conjunction with the above route with pickup points on SR 20 and SR 525. Closed door service between Clinton and SeaTac.

ALTERNATE ROUTE: In the event that the Clinton-Mukilteo Ferry service is not available, or there are no other reservations for passengers on the above named route south of Oak Harbor, the company may for any individual trip elect to utilize the following alternate route: SR 525, SR 20, Interstate 5 via Burlington, with closed-door service between Oak Harbor and hotels and motels within a 1-mile radius of the SeaTac International Airport.

CLOSED DOOR SERVICE: When necessary to circumvent traffic conditions that would negatively impact its schedule, the company may use any combination of roads and highways to provide its closed door service between Oak Harbor and SeaTac; Clinton and SeaTac, Oak Harbor and hotels and motels within a 1-mile radius of SeaTac; and BETWEEN Deception Pass and Sea Tac International Airport and BETWEEN the Clinton Ferry and SeaTac International Airport.

NOTE: Nothing in this certificate authorizes transportation between SeaTac International Airport and hotels and motels within a 1-mile radius of SeaTac.
