- On July 20, 2011, Miller Schmer, Inc., d/b/a Seattle Express (Seattle Express or Applicant), filed with the Washington Utilities and Transportation Commission (Commission) an application for an extension of Certificate No. C-1052 for a Certificate of Public Convenience and Necessity to Operate Motor Vehicles in Furnishing Passenger and Express Service as an Auto Transportation Company (Application). Notice of the Application was published in the Commission's weekly Docket of August 2, 2011.
- 2 The Applicant requests its existing authority be revised to include passenger service between cruise line terminals 66 and 91 and the Sea-Tac Airport.
- 3 On August 31, 2011, Shuttle Express, Inc., d/b/a Shuttle Express, filed a protest to the Application.
- 4 **STATUTORY AUTHORITY**: The Commission has jurisdiction over this matter under RCW Title 81, and has legal authority to regulate persons seeking to furnish auto transportation services under RCW 81.68 and WAC 480-30. The statutes that apply to this matter include RCW 80.01, RCW 81.04, RCW 81.28, and RCW 81.68, including but not limited to RCW 80.01.040, RCW 81.04.020, RCW 81.68.030 and

RCW 81.68.040. The rules that apply to this matter include those within WAC 480-30 and WAC 480-07.

- 5 **ISSUES.** The issues in this proceeding include whether modifying the existing Seattle Express authority, for the service it proposes, is necessary and is otherwise consistent with the public interest, and whether other carriers authorized to serve in the requested territory do not or will not provide this service to the satisfaction of the Commission. In addition, the Commission will consider whether to consolidate this proceeding with Dockets TC-111446¹ and TC-111643² and/or with Docket TC-111619.³
- THE COMMISSION GIVES NOTICE That the Commission will hold a prehearing conference in this matter at 1:00 p.m., on November 22, 2011, in Room 108, First Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington. The prehearing conference is set at the same time as the prehearing conference in Dockets TC-111446, TC-111619, andTC-111643.
- 7 The Commission sets a prehearing conference to discuss preliminary matters, the hearing process, and to formulate the issues. The purpose of the prehearing conference is to consider requests for intervention, resolve scheduling matters including hearing dates, to identify the issues in the proceeding and determine other matters to assist the Commission in resolving the matter, as listed in WAC 480-07-430.
- 8 **INTERVENTION:** Persons who wish to intervene should file a petition to intervene in writing at least three business days before the date of the prehearing conference.
