I'm sorry to tell you that on August 6 the commission denied your application for a charter permit because you did not file a request for a hearing in a timely manner.

Background:

On July 16, The commission's transportation safety staff filed a notice stating they intended to recommend denial of your application for a charter permit based on your firm's lack of safety fitness. This was based on a

February safety inspection of Discovery Tours by commission staff that documented numerous serious safety violations that resulted in an unsatisfactory safety rating. Commission staff also presented information that showed common ownership and use of equipment between Discovery and your company sufficient to conclude that you were in effect the same company seeking to operate under a different name.

The commission's Record Center mailed this notice of intent to deny to the mailing address included with your application – a post office box in Rochester, Washington and emailed the notice to your email address above. We did not serve it on a registered agent because you did not include a contact information for an agent in the paperwork filed with your application.

This notice requested that you request a hearing no later than July 30. You did not respond in a timely manner, your email below and the attached request for hearing was received on August 4. The commission issued an order denying your charter permit application on Aug. 6 and it was sent to you that day in the same manner as the July 16 notice – via the US Post Office and by email. I have attached a copy of that order for your review.

Please review this information and respond as soon as possible telling me what you would have me do to assist you.
