- On February 10, 2015, Five Stars Moving & Storage, LLC (Five Stars Moving or Applicant) filed with the Washington Utilities and Transportation Commission (Commission) an application for authority to operate as a household goods carrier in the state of Washington under Revised Code of Washington (RCW) 81.80 and Washington Administrative Code (WAC) 480-15.
- On March 20, 2015, the Commission issued a Notice of Intent to Deny Application for Permanent Authority; Notice of Opportunity for Hearing in this matter based on its review and investigation of the application. The Commission alleges that the Applicant's owner, William Anthony Trick, has a criminal conviction for child molestation in the first degree and was incarcerated for his conviction from November 27, 1999, until May 21, 2004. The Notice provided Five Stars Moving the opportunity to request a hearing to contest the factual allegations in writing by April 3, 2015.
- On March 30, 2015, Five Stars Moving filed with the Commission a Request for Hearing.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether Five Stars Moving's application for permanent authority should be denied due to the concerns raised after Staff's review and investigation of the application.
