For \$1,000 penalty from the previous case TE-151029, arrangements have been made with the collections agency of \$100 every month until the end. We will include the correspondence email.


We may also decide to shorten the term the soonest possible, should we have more means.

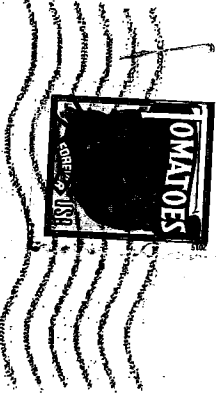
