- On September 29, 2016, Cheryl Ann Ball d/b/a Acme Moving Labor (Acme Moving Labor or Applicant) filed with the Washington Utilities and Transportation Commission (Commission) an application for authority to operate as a household goods carrier in the state of Washington under Revised Code of Washington (RCW) 81.80 and Washington Administrative Code (WAC) 480-15.
- On October 19, 2016, the Commission issued a Notice of Intent to Deny Application for Permanent Authority and Notice of Opportunity for Hearing in this matter based on its review and investigation of the application. The Commission alleges that the Applicant's operation's manager, Kedric D. Jackson, has an Assault 4 conviction from 2011. Mr. Jackson's history also includes convictions for assault in 1986, 1996 and 2009, theft in 2006, and manufacture/delivery/possession of a controlled substance with intent to deliver in 2000. The Notice provided Acme Moving Labor the opportunity to request a hearing to contest the factual allegations by October 31, 2016.
- 3 On October 31, 2016, Acme Moving Labor filed with the Commission a Request for Hearing.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether Acme Moving Labor's application for permanent authority should be denied due to the concerns raised after Staff's review and investigation of the application.
