RE: *Washington Utilities and Transportation Commission v. Can't Stop Moving LLC*  
Commission Staff's Response to Proposed Payment Schedule  
Docket TV-170293

Dear Mr. King:

On June 29, 2017 staff submitted its response to Can't Stop Moving LLC's (Can't Stop Moving) proposed payment schedule for penalties assessed in docket TV-170293. Staff wishes to correct an error in the proposed payment schedule.

On June 19, 2017, the Washington Utilities and Transportation Commission issued Order 01 in docket TV-170293 which granted Can't Stop Moving's request for mitigation of a \$51,900 penalty to \$25,400. The Commission further suspended a \$15,400 portion of the penalty for two years, and agreed to waive it, provided that Can't Stop Moving not incur any repeat critical violations of WAC 480-15 and Title 49 C.F.R. and pay the remaining \$10,000 penalty or file jointly with Staff a mutually agreeable payment arrangement within 20 days of the effective date of this Order.

On June 29, 2017, Mr. Eric Michelson of Can't Stop Moving contacted Commission Staff with a proposed penalty payment schedule consisting of 20 monthly payments of \$500 per month.

Staff supports the payment plan proposed by Right Turn Moving, under the following conditions:

1. The company will make twenty monthly installments of \$500, for a total of \$10,000.

2. Each payment will be due and payable on the fifteenth day of each month, beginning July 15, 2017. Monthly payment due dates may be adjusted to the next business day when the fifteenth day falls on a weekend or holiday.
3. If the company fails to pay any installment by the due date, or fails to pay at least the minimum amount due, the entire remaining balance of payments will become immediately due and payable.
