TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) will accept comments on Avista Corporation's (Avista or Company) integrated resource plans for natural gas service. An integrated resource plan (IRP or Plan) describes the energy supply and conservation designated to meet current and future energy demands at the lowest reasonable cost and risk to the utility and its ratepayers.
