I. INTRODUCTION

On May 6, 2019 Dolly, Inc. ("Dolly" or "the Company") filed a Proposed Compliance Plan ("Plan" or "PCP") pursuant to the Washington Utilities and Transportation Commission entering Order 01 on February 14, 201, which denied Dolly's household goods carrier permit application without prejudice, filed in this docket on July 17, 2018. In conjunction with the Plan, Dolly files this individual tariff pursuant to Administrative Code Section WAC 480-07-520(1) which provides:

- (1) To file an individual tariff or to amend an approved individual tariff already on file with the commission, a carrier must submit all of the following:
 - (a) A cover letter requesting permission to publish and file an individual tariff. The letter must describe the reasons the carrier believes permission should be granted. The letter should state the reasons it is impractical for the commission to publish a tariff for the commodities or services contained in the proposed tariff.
 - (b) Two copies of the proposed tariff. The proposed tariff must comply with the tariff drafting standards in chapter 480-149 WAC. The proposed tariff must contain all rates, charges, and rules the company will use if granted approval to publish and file an individual tariff.
 - (c) Data showing that the rates and charges contained in the proposed tariff are fair, just, reasonable and sufficient.

- Item 85 a. Rates are calculated on the basis of: the specific item(s), the distance and time between the point of origination and the destination, environmental factors at the point of origination and the destination, and the day and time of the request.
 - b. Flat fees may be charged for trips related to specific items.
 - c. Rates may increase or decrease in real time for the purpose of balancing supply and demand. At times of tight supply, such as special events or holidays, surge pricing goes into effect.
 - d. In all situations, the prospective customer will be advised of the rate charged and will receive a guaranteed price quote prior to booking.
