### TO ALL INTERESTED PERSONS:

On November 8, 2023, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser an Emergency Rulemaking Order (CR-103E), amending WAC 480-93-015 to create an exemption for the odorization and sniff test requirements in certain pipeline facilities for circumstances where sniff tests would be hazardous to human health. On December 13, 2023, the Commission filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider permanent revisions to WAC 480-93-015 to preserve the exemption beyond the 120 day effective period of the emergency rule amendment and add the clarification that when the exemption applies, operators must be able to otherwise demonstrate impurity levels.

On January 23, 2024, the Commission filed a Notice of Proposed Rulemaking (CR-102) with the Office of the Code Reviser at WSR 24-03-143. The Commission did not receive any comments on the CR-101 and now proposes rules for permanent adoption subject to review and comment by interested persons.
