## TO ALL INTERESTED PERSONS:

On April 7, 2010, the Washington Utilities and Transportation Commission (Commission) initiated this proceeding to consider development of a policy statement and potential revisions to state universal service policies in response to a request from six state legislators.

On November 29, 2012, the Commission released its Report Reviewing State Telecommunications Policies on Universal Service (Report) in which it set forth a recommended approach to establishing a state universal service fund (state USF). Since release of the Report, Commission Staff has conducted individual earnings reviews of the incumbent telephone companies that could be eligible for assistance from a state USF.

As a further follow up to the Report, the Commission has prepared draft legislation to establish a state USF to assist the state's smaller incumbent telephone companies in meeting their universal service obligations. A discussion draft of agency request legislation is attached to this Notice (Discussion Draft).
