TO ALL PARTIES:

The Commission entered its Order 06, Final Order Approving and Adopting, Subject to Conditions, Multiparty Settlement Agreements and Authorizing Transaction, in Docket UT-090842 on April 16, 2010. The Order required by its terms that Frontier Communications Northwest, Inc., make certain compliance filings, including filing revised tariff sheets and exchange maps. Order 06 authorizes the Commission's Executive Director and Secretary to approve the required filings, by letter, if they comply with the terms of the Order.

On December 16, 2010, Frontier Communications Northwest, Inc., filed revised tariff sheets and the exchange maps. The purpose of these compliance filings is to reflect the Company's name change from Verizon Northwest, Inc., to Frontier Communications Northwest, Inc. There is no other change to the content of the tariffs. Given the nature of these filings and the voluminous tariff sheets, a list of individual tariff sheets is not attached to this letter. The tariff sheets and the exchange maps included in the tariff volumes identified below are available for review in the Commission's offices at 1300 S. The Commission has examined the filings and it appears that the tariff revisions in the following volumes, constituting the Company's full tariff, comply with the terms of the Order:
