QWEST CORPORATION'S ERRATA TO ATTACHMENT C OF ITS COMMENTS IN RESPONSE TO COMMISSION'S ORDER GRANTING MOTION TO STAY PROCEEDINGS AND REQUESTING COMMENT

Qwest Corporation ("Qwest") submits these Errata to Attachment C of its Comments in Response to Commission's Order Granting Motion to Stay Proceedings and Requesting Comment ("Comments"). In support, Qwest states:

1. Attachment C to Qwest's comments contained a red-lined version of the Federal Communications Commission's rules, showing which rules were vacated, remanded or are still in effect as the result of the court's decision in *United States Telecom Association v. Federal Communications Commission*, 359 F.3d 554 (D.C. Cir. 2004) ("*USTA II*").

2. Due to an oversight, rules related to high capacity loops, which the court vacated, were not shown in strikeout in Attachment C. See *USTA II*, 359 F.3d 554, 573-75. Qwest has attached to these errata a revised Attachment C, in which rules related to high capacity loops are shown in strikeout.

3. Qwest is aware of the fact that some or all of the competitive local exchange carriers (“CLECs”) disagree with this interpretation of the *USTA II* decision.

4. Nothing in these errata change Qwest’s Comments, or Qwest’s ultimate recommendation that the Commission allow good faith negotiations of commercial agreements and existing interconnection agreements to proceed, and that there is no need at this time for further action by the Commission.


