The Commission's intent is that any *newly joining the proceeding* Washington CLECs wishing to participate in the six-month review must comply with next Monday's appearance deadline, as set out in Order 05 and quoted in your e-mail. For those Washington CLECs who are already parties, whether as co-petitioners with Qwest or as entities granted intervenor status under the original subject matter of this docket (as was the case with your clients), there is no need to restate your intentions to remain as parties now that the case has been converted to a six-month review.

Thanks for seeking the clarification. I believe I've cc'd all other parties to this matter, but I've also sent a copy of this e-mail to the Records Center so it will become part of the record for this case.
