Dear Mr. King,

On June 16, 2011, the Washington Utilities and Transportation Commission granted YourTel America ("YourTel") Eligible Telecommunications Carrier status in the State of Washington via an order effective that day. It included language that YourTel is to abide by the following:

On a quarterly basis beginning with the quarter ending on September 30, 2011, YourTel shall provide the number of Lifeline customers that it enrolls each month. YourTel shall also report the number of deactivated Lifeline customers each month by service plan and the reasons for deactivation (e.g., no usage for 60 consecutive days, annual verification unsuccessful, or voluntary exit). Quarterly reports shall be filed with the Commission no later than 30 days after the end of each quarter.

YourTel America hereby submits in compliance with the preceding its Fourth Quarter 2013 Report. The information contained within this filing has been marked and submitted as Confidential. This is the redacted, public version of the filing.
