Tell the UTC to Vote Yes to Extend Net Metering



If you are a fan of solar and a customer of Puget Sound Energy (PSE) we have important news for you. And we need your help.

PSE has almost reached their minimum legal requirement for [net metering](#). Once they reach this threshold, they have the option to change the compensation rate for new net metered solar systems.

But PSE has formally expressed their intention to maintain the existing net metering rate until at least December 31, 2025, to allow time for completion of a comprehensive and scientific value of solar study. The study would be used to determine the most fair and equitable rate for new net metered customers going forward.

However, the Washington Utility and Trade Commission (WUTC), who must approve this request, has expressed concerns.

PSE and WASEIA are Asking for Your Help

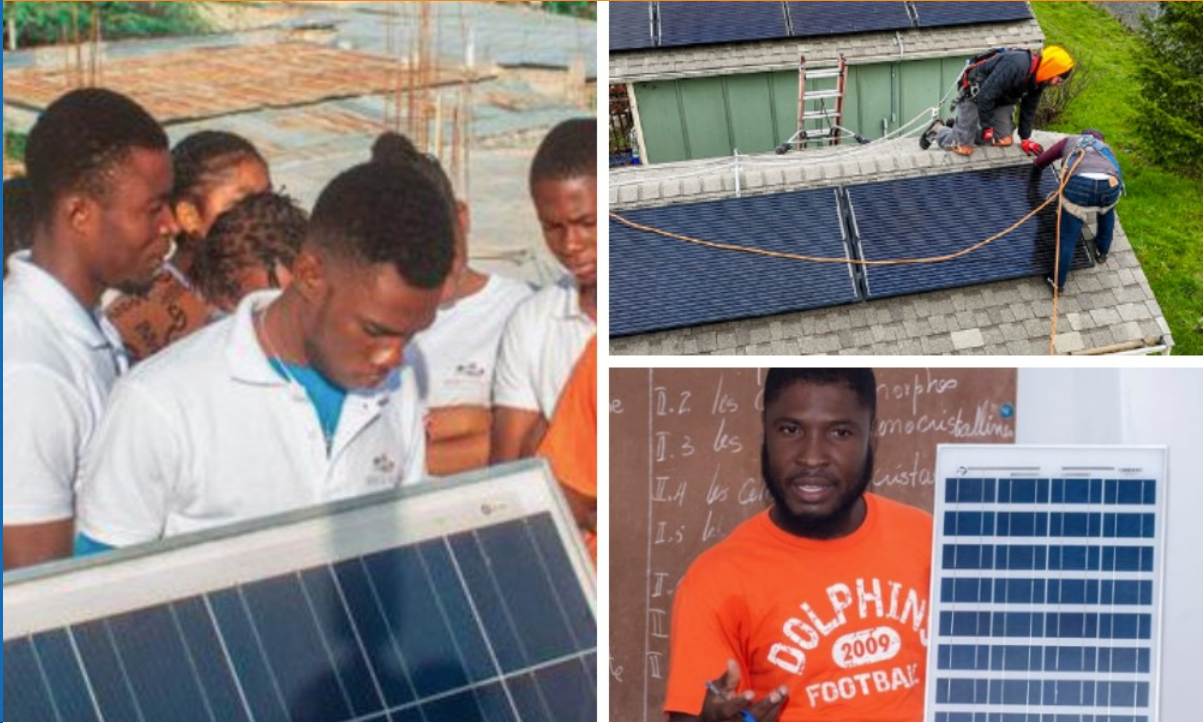
