In Exhibit No. ___ (PMW-4), Page 1.2, Return on Rate Base Requested, the rate of return used is not 8.754% but 8.754329%. Please provide this exhibit using an 8.754% rate of return.

BENCH REQUEST NO. 3:

Please provide the calculations for the following adjustments: 3.1, 3.2, 3.5, 3.7, 5.1, 5.2, and 8.16, Exhibit No. ___ (PMW-2), Pages 3, 5 and 8, showing the effects of revenue sensitive taxes and expenses as shown in the conversion factor. Please explain and provide support for the conversion factor you have used for each of these adjustments.

BENCH REQUEST NO. 4:

In Exhibit No (PMW-8), Page 2.2, column entitled "Washington," the results of
operation in this column shows different amounts for expenses, net operating income,
and rate base than is shown in Exhibit No (PMW-4), Page 2.2. Please explain the
differences and provide support for the calculations.

BENCH REQUEST NO. 5:

Please provide the revenue, expenses, taxes, net operating income, rate base, conversion factor used, and rate of return used, to calculate the revenue requirement for each of the adjustments shown on Page 3 of Exhibit No. ___ (PMW-5T).

BENCH REQUEST NO. 6:

Please provide the revenue, expenses, taxes, net operating income, rate base, conversion factor used and rate of return used, to calculate the revenue requirement for each of the adjustments shown on Page 5 of Exhibit No. ___ (PMW-5T).

BENCH REQUEST NO. 7:

Please identify each of the adjustments that are included in Exhibit No. ___ (PMW-8), Page 2.2, "Adjustments" column.

TO COMMISSION STAFF:

The adjusted rate base in Staff's case is identified as \$541,157,929 in Exhibit No. ___ (TES-3), Page 1, line 56, column 5, but the rate base used in Staff's calculation of adjustment 7.1 is \$543,355,900. Please explain the difference and provide the calculation for the adjustment.

In its adjustment 3.2 in Exhibit No (TES-3), Page 6, Staff has reduced the revenue by
the revenue sensitive taxes and other items used in the conversion factor. Should these
revenue sensitive items also be used in calculating adjustments 3.1, 3.4, 3.5, 3.7, 5.1 in
Exhibit No (TES-3) Page 10, and 8.16 in Exhibit No (TES-3), Page 21? Please

provide the calculation for each of the above adjustments reflecting the appropriate revenue sensitive expenses.

Should Staff adjustments 8.1 and 8.4 be considered contested adjustments or uncontested adjustments? Please provide a corrected list of uncontested adjustments in the same format as Exhibit No. ___ (TES-4).
