**Q. Please state your name and business address.**

A. My name is Roger Garratt. My business address is 10885 NE 4th Street, P.O. Box 97034, Bellevue WA 98009-9734.

**Q. By whom are you employed and in what capacity?**

A. I am employed by Puget Sound Energy, Inc. (“PSE”) as Director of Resource Acquisition within the Energy Resource Group.

**Q. What are your duties as Director of Resource Acquisition within the Energy Resource Group?**

A. My present responsibilities include overseeing the acquisition of electric resources for PSE, commencing with the Request for Proposal process and culminating in the execution and closing of all of the definitive agreements necessary to acquire a resource. In addition, I am responsible for the construction and operation of PSE’s wind projects and contracts for long-term electric supply and transmission service.

1 **Q. Briefly describe your education and relevant employment experience.**

2 A. I graduated from the University of Nebraska with a Bachelor of Science degree in  
3 electrical engineering. I also received a Masters of Business  
4 Administration (MBA) degree from Union College, Schenectedy, NY.

5 I have over 20 years of diversified experience in the energy industry, including  
6 development, acquisitions, capital equipment sales, after-market parts and service  
7 sales and marketing, and extensive knowledge of western energy markets and  
8 organizations.

9 From 1977 to 1991, I worked at General Electric, where, among other positions,  
10 I was a Turbine Sales Manager responsible for sales of power generation  
11 equipment and associated services in the seven-state, Northwest Region.

12 From 1991 to 1994, I was employed at the J. Makowski Company, Inc., a Boston-  
13 based energy development company, purchased by Pacific Gas & Electric  
14 National Energy Group ("PG&E NEG") in 1994. At J. Makowski Company, Inc.,  
15 I established a market presence for the company in the Northwest region and  
16 initiated development of two projects in Washington.

17 From 1994-2002, I was employed at PG&E NEG, where I was employed as  
18 Director of Project Development. In this capacity I was responsible for managing  
19 all aspects of project development, including the La Paloma Generating Project  
20 (from 1997-2000) and the Umatilla Generating Project (from 2000-2002).

I joined PSE at the end of March 2003 as the Manager of Project Development.  
In March 2004, I was promoted to Director of Resource Acquisition. Prior to my  
work on the 2005 RFP and the Goldendale Generating Station acquisition, I was
