
In accordance with WAC 480-07-640, Company A requests approval of the fully negotiated amendment to an interconnection agreement, as described below:

Amendment No. 21 amends this agreement by adding terms and conditions relating to xDSL Capable Loops as set forth in Attachments 1-3 and Exhibit A to this amendment

This amendment amends the interconnection agreement which went into effect on August 30, 2000 in WUTC Docket No. UT-993007 (current docket number) between Qwest Corporation and McLeodUSA Telecommunications Services, Inc. dba PAETEC Business Services

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. - (3) The laws and regulations of the State of Washington and Commission Orders govern the construction and interpretation of the Amended Agreement. The Amended Agreement is subject to the jurisdiction of the Commission.

The Commissioners, having reviewed the information available in this matter and having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
